“Future Insight e.V.” collects, uses, and processes personal data in connection with its purpose and for events in accordance with the Articles of Association. These include the address details required to issue invitations to meetings and events and to send information by mail or in electronic form (membership administration). In addition, “Future Insight e.V.” uses personal data in line with the purposes stated above in its media (e.g. website, member information, newsletter, etc.). The legal basis for processing is Article 6 (1) b GDPR.
